Summary: On May 23, 2005, Colin E. Cushnie, A Director of Regulatory Policy and Affairs of Southern California Edison Company (SCE), met with Bob Lane, advisor to Cmmr. Bohn, in San Francisco. Written materials (attached to the notice) were used. Cushnie stated that all the workshop comments filed by the generation community in support of the 'Top Down' Resource Adequacy methodology explicitly or implicitly call for the immediate creation of a bilaterally traded capacity-only product for Load Serving Entities (LSEs) to procure to demonstrate compliance with the Commission's adopted Resource Adequacy requirements. Cushnie indicated that the immediate creation of a capacity-only product without the centrally administered market structure and safeguards found in the Eastern United States' capacity markets would expose customers and LSEs to undue risk. Summary: On May 24, 2005, Keith McCrea, counsel to the California Manufacturers & Technology Association, had two separate telephone conversations with Belinda Gatti, advisor to Cmmr. Brown, and Laurence Chaset, advisor to Cmmr. Grueneich. McCrea discussed the draft decision's (DD) treatment of CARE cost allocation.
