- 9/19/05 **C.04-10-024** Pac-West Telecomm, Inc., Complainant, vs. AT&T Communications of California, Inc., Teleport Communications Group of San Francisco, Teleport Communications Group of Los Angeles, Teleport Communications Group of San Diego, Defendants; **Presiding Officer's Decision of ALJ McKenzie.**

This decision grants the complaint filed by Pac-West Telecomm, Inc. against AT&T Communications of California, Inc. Pac-West alleges that AT&T is obliged to pay the termination charges in Pac-West's intrastate tariff for traffic that originates on AT&T's network and is terminated on Pac-West's network. AT&T argues that it is not obliged to pay such charges, because virtually all of the AT&T traffic that Pac-West terminates is "ISP-bound" within the meaning of the FCC's "ISP Remand Order" (16 FCC Rcd 9151), and that under ¶ 81 of that order, such traffic must be exchanged on a "bill-and-keep" basis. This decision concludes, however, that AT&T cannot rely on ¶ 81 of the ISP Remand Order, because AT&T has not made the "mirroring offer" required by ¶ 89 of the ISP Remand Order. Since AT&T does not dispute that if the termination charges are computed according to the Pac-West intrastate tariff applicable here, the amount due would be \$7,115,014.16, the decision directs AT&T to pay Pac-West that amount. The decision also concludes, however, that AT&T is not obliged to pay Pac-West interest and late charges on this amount. This proceeding is closed.
