**BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA**

In the Matter of the Application of Adane Kinfu Tedla doing business as 1 SHUTTLE for authority to operate as an on-call, door-to-door, Passenger Stage Corporation between points in the following Counties: San Francisco, Alameda, Contra Costa, Santa Clara, Solano, Marin and San Mateo, and the International Airports located in San Francisco, Oakland and San Jose; and to establish a Zone of Rate Freedom.

**DECISION DISMISSING APPLICATION**

**Summary**

This decision dismisses the application of Adane Kinfu Tedla (Applicant), an individual, for a certificate of public convenience and necessity to operate as a passenger stage corporation (PSC) and authority to establish a zone of rate freedom (ZORF).

**Discussion**

The application requests authority, pursuant to Pub. Util. Code § 1031 et seq., to operate as an on-call PSC between points in seven Northern California counties, on the one hand, and San Francisco, Oakland, and San Jose International Airports, on the other hand; and to establish a ZORF, pursuant to Pub. Util. Code § 454.2. The Consumer Protection and Safety Division (CPSD) mailed a letter to Applicant on four occasions<sup>1</sup> requesting additional information

regarding Applicant's experience, the equipment he intends to operate, and his request for a ZORF. Applicant failed to respond by submitting the requested information, even after CPSD staff contacted him by telephone. The application should therefore be dismissed.

**Comments on Proposed Decision**

The proposed decision of the Examiner in this matter was mailed to Applicant in accordance with Pub. Util. Code § 311(g)(1) and Rule 14.3 of the Rules of Practice and Procedure. No comments were received.

**Assignment of Proceeding**

Richard Clark is the assigned Examiner in this proceeding.

**Findings of Fact**

1. Applicant requests authority to operate as a PSC and to establish a ZORF.
2. Applicant failed to respond to four written requests by CPSD for additional information.
3. There is no reason to keep this proceeding open.

**Conclusion of Law**

The application should be dismissed.

**IT IS ORDERED** that:

1. The application of Adane Kinfu Tedla is dismissed.

2. This proceeding is closed.
