**SUMMARY**

This resolution revokes the Certificate of Public Convenience and Necessity of AT&T Broadband Phone of California, LLC d/b/a MediaOne Telecommunications of California, Inc. (MediaOne) as requested by the company.

**BACKGROUND**

MediaOne (formerly known as Continental Telecommunications of California and MediaOne Telecommunications of California, LLC) filed for its Certificate of Public Convenience and Necessity (CPCN) as a facilities-based Competitive Local Exchange Carrier in Petition 54. Authority was granted in Decision 95-12-057. AT&T Broadband was also granted inter-exchange authority in Decision 98-04-020. The company filed its initial tariff on September 23, 1996, and the tariff became effective on October 7, 1996.

**DISCUSSION**

The company filed an advice letter dated February 7, 2002, in which it stated that there are no customers served from the MediaOne tariff and therefore it requests voluntary revocation of its CPCN and Utility Identification Number U-5549-C. There is another AT&T Broadband Phone of California, Inc. d/b/a People Link, and this company will continue to do business in California.

Telecommunications Division (TD) recommends that the request for revocation be granted and that the company's Utility Identification Number be cancelled. TD's Public Programs Branch has determined that the company's surcharge accounts have no unremitted balances.

This is an uncontested matter in which the resolution grants the relief requested. Accordingly, pursuant to PU Code Section 311 (g)(2), the 30-day period for public review and comment is being waived.

### **FINDINGS**

1. MediaOne obtained its Certificate of Public Convenience and Necessity in Decision 95-12-057.
2. The company requested that its CPCN be revoked in an advice letter to the Commission dated February 7, 2002.
3. The company's CPCN should be revoked and its Utility Identification Number should be cancelled.

### **THEREFORE, IT IS ORDERED that:**

1. The Certificate of Public Convenience and Necessity granted to AT&T Broadband Phone of California, LLC d/b/a MediaOne Telecommunications of California, Inc. is revoked.
2. The company's Utility Identification Number, U-5549-C, is cancelled and will not be reissued.

This Resolution is effective today.
