**ADMINISTRATIVE LAW JUDGE'S RULING
CORRECTING ATTACHMENT A TO NOVEMBER 15, 2005 RULING**

It has come to my attention that Attachment A to my November 15, 2005 ruling (i.e., Administrative Law Judge's Ruling Regarding Confidentiality of Portions of Prepared Testimony and Stipulation to Mark Exhibits for Identification) contains two errors. Attachment A (1) fails to indicate that Exhibits 102, 103 and 104 had not been identified for the record in a formal way, and (2) misidentifies Exhibits 200, 201, 202, and 203 as the prepared testimony of various witnesses sponsored by "CPSD," rather than "CCSF."
