**ADMINISTRATIVE LAW JUDGE'S RULING
DIRECTING THE FILING OF EXHIBIT 12 BY APRIL 25, 2008**

At the April 10, 2008 hearing, Ms. Sanders, representing the appellant DMK International, Inc., dba New Life Charters, stated that she had a cancelled check written to the California Department of Motor Vehicles (DMV) on June 21, 2006, check number 263, and that this check establishes when she enrolled her employees in the DMV's pull notice program.¹ The undersigned administrative law judge reserved Exhibit 12 for a copy of the front and back of the check and Ms. Sanders agreed to bring the check to the Commission's Los Angeles Office for photocopying on April 11, 2008.

To date, this late-filed exhibit has not been received.

Therefore, **IT IS RULED** that:

1. The appellant is directed to serve all parties on the attached service list a legible photocopy of both sides of check number 263 no later than Friday, April 25, 2008. This should be done by first class mail.
