**APPLICATION OF SOUTHERN CALIFORNIA EDISON COMPANY (U 338-E)
FOR APPROVAL OF ITS CHARGE READY 2 INFRASTRUCTURE AND MARKET
EDUCATION PROGRAMS**

I.

INTRODUCTION

Pursuant to Articles 1 and 2 of the Rules of Practice and Procedure of the California Public Utilities Commission (“Commission” or “CPUC”), Decision (“D.”) 16-01-023,¹ and Commissioner Carla Peterman’s September 14, 2016 Assigned Commissioner Ruling Regarding the Filing of Transportation Electrification Applications Pursuant to Senate Bill 350 (“ACR”);² Southern California Edison Company (“SCE”) hereby respectfully files this application and requests that the Commission approve its Charge Ready 2 programs, as described herein. SCE’s proposal consists of this application and supporting testimony (preliminarily identified as Exhibit SCE-01). The supporting testimony also provides additional details regarding SCE’s proposed ratemaking treatment for its proposal.

II. BACKGROUND

The State of California has called for a 40 percent reduction in GHG emissions from 1990 levels by 2030 and an 80 percent reduction by 2050. To meet these goals, California must reduce emissions at more than three times the annual rate achieved between 2004 and 2015. The transportation sector represents almost 45 percent of California’s GHG emissions, and is the largest GHG-emitting segment in California. Significant reductions in the transportation sector are necessary if California is to reach its goals. SCE’s Charge Ready 2 will help put California on a path to achieving its GHG goals and meeting its quality requirements by encouraging and facilitating transportation electrification (“TE”).

The Charge Ready 2 programs were developed to support California’s policies to reduce greenhouse gas (“GHG”) and air pollutant emissions and to help meet the state’s zero-emission vehicle (“ZEV”) goals. On October 30, 2014, SCE filed Application (“A.”) 14-10-014 with the Commission, requesting approval of its Charge Ready and Market Education Programs. In that application, SCE proposed to implement the Charge Ready and Market Education Program in two phases: Phase 1 (“Phase 1 Pilot”), a one-year pilot to deploy infrastructure for up to 1,500 light-duty EV charging stations and complementary market education, and Phase 2, a four-year program to deploy infrastructure for an additional 28,500 light-duty EV charging stations and complementary market education. Given that the Charge Ready and Market Education Program was the first of its kind for SCE, and one of the first in the nation, SCE and other parties to the proceeding agreed to start by implementing the Phase 1 Pilot, which the Commission ultimately approved.³

To date, SCE has deployed infrastructure to support 1,003 charge ports at 65 customer sites, nearly 50 percent located in disadvantaged communities. The Phase 1 Pilot allowed SCE and others to assess the viability of the make-ready premise, lay the groundwork for the

programs proposed in this application (“Charge Ready 2”) with the large-scale deployment of light-duty charging infrastructure, and incorporate the lessons learned through the Phase 1 Pilot into SCE’s internal processes and this proposed program expansion.

With the successful completion of the Phase 1 Pilot and the continuing market need for more EV charging infrastructure, the time has come to implement Charge Ready 2 and move to widescale deployment of EV infrastructure, in support of California’s critical GHG and air quality goals.

III.

SUMMARY OF SCE’S REQUEST

In this application and supporting testimony, SCE requests Commission approval of Charge Ready 2, the second phase of SCE’s Charge Ready and Market Education Program. Approval of this application would allow SCE to continue to support the development and expansion of the TE pathway that SCE launched in 2014 with its Charge Ready and Market Education Program Application and began implementing in 2016 with the Phase 1 Pilot. With Charge Ready 2, SCE proposes a portfolio of programs aimed at accelerating light-duty electric vehicle (“EV”) adoption by making EV charging available to more customers, addressing barriers to EV adoption, and promoting EV awareness and grid benefits.

Charge Ready 2 is a four-year program that will support and accelerate light-duty EV adoption, in line with California’s goals of substantially reducing GHG emissions and criteria pollutants by 2030. Key elements of Charge Ready 2 include: (1) supporting and accelerating adoption of EVs on a trajectory to reach at least five million, and consistent with reaching seven million, new light-duty EVs by 2030; (2) installing, operating and maintaining the “make-ready” infrastructure to support 32,000 charge ports, providing rebates to offset a portion of the charging station cost, and including direct current fast charging (“DCFC”) ports; (3) creating new options that provide a range of unique solutions for charging needs in the multi-unit dwelling (“MUD”) segment, including new construction rebates that will support 16,000 additional charge ports; (4)

addressing needs in low-income and disadvantaged communities, including a commitment to deploy a minimum of 30 percent of Charge Ready 2's charging infrastructure in disadvantaged communities; (5) providing a comprehensive marketing, education and outreach ("ME&O") program for all customers; and (6) incorporating lessons learned from the Phase 1 Pilot.

In this application, SCE seeks authority to:

- i. Proceed with the Charge Ready 2 programs over a four-year period, at an estimated cost of \$760.1 million. Charge Ready 2 will include the deployment of infrastructure and rebates to support 48,000 EV charging stations, as well as broad ME&O activities;
- ii. Separately record Charge Ready 2 costs in the existing Charge Ready Program Balancing Account ("CRPBA") to provide for the recovery of Charge Ready 2 recorded revenue requirements, which include recorded Charge Ready 2 incremental costs effective upon a Commission decision in this application proceeding; and
- iii. Limit the reasonableness review of the CRPBA to ensuring all recorded costs are associated with Charge Ready 2 activities as defined and adopted by the Commission in the Charge Ready 2 proceeding.

IV.

ORGANIZATION OF SCE TESTIMONY

SCE's testimony submitted in support of this application is comprised of five chapters, summarized as follows:

Chapter I – Introduction provides a brief summary of SCE's proposals and the impetus for this application;

Chapter II – Transportation Electrification Transformation: Moving from Pilot to Scale provides background on the need for and the benefits of TE, describes how increased TE will

help achieve the state’s environmental goals, and explains the importance of transitioning from the pilot to a broader program to support the needed growth of TE;

Chapter III – SCE’s Charge Ready 2 Portfolio describes SCE’s proposed infrastructure, rebate, and ME&O programs, implementation plans, and projected costs;

Chapter IV – SCE’s Charge Ready 2 Satisfies Statutory and Regulatory Guidelines describes how the Charge Ready 2 proposal complies with all applicable regulatory and statutory requirements; and

Chapter V – Cost Recovery discusses the estimated revenue requirement and proposed cost recovery for and rate impact of Charge Ready 2.

V.

EXECUTIVE SUMMARY

In 2016, the Commission authorized SCE to implement the Phase 1 Pilot to deploy the “make-ready” infrastructure needed to support EV charging and provide education about EVs and the benefits of fueling from the grid. SCE launched the Phase 1 Pilot in May 2016. Building upon the strength of the completed Phase 1 Pilot and recognizing that utilities are a driving force in the acceleration of TE, SCE proposes the broader next step of its TE program—Charge Ready 2. This request for \$760.1 million (2018\$) will support and accelerate light-duty EV adoption, in line with California’s goals of substantially reducing GHG emissions and criteria pollutants by 2030.

In Charge Ready 2, SCE proposes to support light-duty EV adoption by continuing its deployment of electric infrastructure to provide EV charging at customer sites throughout SCE’s service area where drivers typically park for two hours or more. Charge Ready 2 will make EV charging available to more customers, address barriers to EV adoption, and promote EV awareness and grid benefits. Zero-emission vehicles are critical to California’s comprehensive climate and air quality plans. The Charge Ready 2 Portfolio will help California reach its climate and clean air goals by reducing GHG emissions broadly and decreasing criteria air

pollutants to improve local air quality. Increasing transportation electrification will also create downward pressure on customer rates and help integrate renewable generation into the electric grid. In this application and supporting testimony, SCE hereby seeks approval from the Commission for its Charge Ready 2 Program. The program specifics are set forth below, and in more detail in SCE’s testimony (preliminary identified as Exhibit SCE-01).

VI.

SCE’S CHARGE READY 2 PROPOSAL

If approved, Charge Ready 2 will help California meet its climate and air quality goals by supporting a trajectory of light-duty EV adoption to reach at least five million, and consistent with reaching seven million, electric vehicles in California by 2030. The Charge Ready 2 Portfolio includes broad and targeted activities that will expand the speed of EV deployment, increase the number of eligible customer sites, and grow the level of engagement related to EVs. Charge Ready 2 focuses on the continued deployment of electric infrastructure programs throughout SCE’s service territory and the development of a robust ME&O program intended to facilitate widespread adoption of EVs. Charge Ready 2 scales the successful programs from the Phase 1 Pilot into a four-year program, while adding new and innovative components.

The Charge Ready 2 Portfolio (the “Portfolio”) contains several programs focusing on overcoming barriers to accelerate EV adoption. The Portfolio includes three infrastructure programs to support construction of approximately 48,000 new EV charging ports. The Portfolio largely follows the infrastructure model developed for the Phase 1 Pilot, where SCE deploys, owns, and maintains the electric infrastructure needed to serve charging equipment for light-duty vehicles (up to and including the make-ready stubs). The infrastructure programs are supported by robust ME&O that targets customers at all levels of the purchase funnel – from customers who have no experience with EVs, to those ready to test drive, to businesses that may be interested in updating their internal-combustion engine fleets—and provides needed information

relating to fleet electrification, access to EV charging, the benefits of fueling from the grid, and EVs’ effect on the state’s GHG and air quality goals. Consequently, the Charge Ready 2 Portfolio includes both broad and targeted activities that increase the speed of deployment, expand the scope of eligible customer sites, and extend the scale of engagement that defined the Phase 1 Pilot.

Table 1, below, provides an overview of the Charge Ready 2 Portfolio, the focus for each program, and which segments they cover. SCE customers who participate in Charge Ready 2 will be given the option of having SCE install, operate and maintain the “make-ready” infrastructure, and site owners may install and own the customer-side infrastructure and receive a rebate for doing so.

SCE's programs provide solutions for communities that face barriers to the installation of TE infrastructure. SCE will offer a turnkey solution where SCE will own and operate charging stations deployed in MUDs and governmental locations. The new construction rebate program will offer an incentive to MUDs that exceed building codes by installing EV charging stations at their sites. Charge Ready 2 targets the needs of low-income and disadvantaged communities by ensuring a minimum of 30 percent of the Charge Ready 2 charging infrastructure is deployed in disadvantaged communities.

SCE projects that seven million light-duty vehicles must be adopted by 2030 for California to meet its 2030 GHG goal and improve air quality.⁴ SCE's proposed Charge Ready 2 program is integral to developing the charging infrastructure required to increase adoption of EVs and encourage EV usage, which in turn will help California meet its environmental goals.

A. Charge Ready 2 Infrastructure Programs

SCE proposes three infrastructure programs to support 48,000 new charge ports, including direct current fast charging ("DCFC"), within SCE's service territory. SCE's programs will support the deployment of charging installations efficiently by factoring in the location, design and construction costs to maintain reasonable fees.

1. Charge Ready Make-Ready Expansion

In the Charge Ready Make-Ready Expansion program, SCE plans to install make-ready infrastructure across workplaces, MUDs, destination centers, governmental locations, and fleets capable of supporting approximately 32,000 charging ports for light-duty electric cars in SCE's service territory over a four-year program. A minimum of 30 percent of the total number of ports will be targeted for placement in disadvantaged communities.

As described in SCE's supporting testimony, this four-year program will put us on a trajectory of infrastructure deployment that will help California meet both EV adoption targets.

SCE will offer customers a rebate to offset the cost of the qualifying charging station and its installation so long as the charging equipment meets the program requirements. SCE will also offer customers the choice to manage and pay for the installation of the customer-side infrastructure with a rebate of up to 80 percent of the infrastructure installation costs.

2. Charge Ready Own and Operate:

As a component of the Make-Ready Expansion program, the Charge Ready Own and Operate program will offer customers in MUDs and governmental locations a turnkey option where SCE will own and operate charging stations deployed at those sites. Participation will be capped at 4,230 charge ports (within the 32,000 ports supported by the Make-Ready Expansion program), or approximately 35 percent of forecasted MUD participation. Under this option, site hosts will be required to meet the contractual needs of the make-ready program (e.g., easement) and pay for all electricity charges, but will not be obligated to purchase or maintain charging stations.

3. Charge Ready New Construction Rebate:

The Charge Ready New Construction Rebate provides a rebate to developers of new MUD buildings to exceed mandatory CALGreen and local jurisdiction building code by installing EV charging stations. The rebate is designed to cover the incremental cost to move a site from “EV capable” to full installation of EV charging stations. The rebate will be up to \$4,000 per port to help pay the cost of that charging station and the installation of infrastructure components in excess of the most stringent mandatory code for each site’s jurisdiction. The rebate will not exceed 100 percent of the installation and charging station costs.

The rebate program will support an estimated 16,000 additional charging ports at MUDs under construction during the four-year program duration. This program complements, and does not duplicate, the other infrastructure components of the Charge Ready 2 Portfolio by targeting only new construction.

B. Charge Ready 2 Marketing, Education, and Outreach Programs

SCE proposes to tackle key EV adoption barriers and address customer needs through a comprehensive ME&O effort intended to improve EV awareness and understanding of the benefits of fueling from the electric grid, and assist residential and business customers as they consider adopting EVs.

SCE proposes three discrete programs to provide SCE customers with specific education and support related to electrifying fleets, EV charging, reducing GHG footprints, and other related TE areas. All three ME&O programs will include specific engagement of customers who face additional socioeconomic barriers and live or work in disadvantaged communities with a concentrated amount of air pollution, largely caused by fossil-fueled vehicles. ME&O will familiarize customers with available EV incentives and rebates that make EVs more affordable, including special state incentives available to customers in disadvantaged communities.

1. EV Awareness Campaign

To increase EV adoption, SCE will develop an EV Awareness Campaign to increase public awareness about EVs, the benefits of EV adoption, and the benefits of fueling from the grid. SCE will implement this broad EV awareness campaign through mass media, direct marketing, outreach through local community organizations, and a new EV Ambassador network.

2. Customer Education Program

The Customer Education Program will build on the proposed EV Awareness Campaign to provide further education on EVs through new, online self-service tools, enhanced education and training materials, hands-on ride-and-drive events and experiential events. SCE intends to develop improved, mobile-optimized tools and customer materials to help potential EV adopters develop an informed opinion and determine if EVs are a right fit for their needs and budget.

3. TE Advisory Services

SCE plans to expand the Phase 1 Pilot TE Advisory Services to include new services for more business customers. These services will primarily focus on technical education and support commercial, governmental, and fleet-operating customers from initial awareness to training, hands-on experiences, and TE-related assessments performed by SCE or its vendors.

C. Revenue Requirement and Cost Recovery

1. Revenue Requirement

To fully implement Charge Ready 2, SCE asks the CPUC to approve SCE's request to recover the revenue requirements associated with no more than \$760.1 million (2018\$) in direct capital expenditures and operation and maintenance ("O&M") expenses, including ME&O.

2. Cost Recovery

SCE proposes to separately record the Charge Ready 2 incremental revenue requirements in its existing CRPBA to provide for the future recovery of Charge Ready 2 revenue requirements associated with all recorded Charge Ready 2-related costs, effective upon a Commission decision in this application proceeding. Each month, SCE will record the following in the CRPBA Charge Ready 2 subaccount: capital-related revenue requirements (debit), including depreciation, return on rate base, property taxes, and income taxes based on recorded capital additions and rate base; recorded incremental O&M costs (debit); Charge Ready 2-related marketing and education costs; and broad EV awareness and marketing expenses. Pursuant to the Commission-adopted process for reviewing other SCE balancing accounts, including the CRPBA for the Phase 1 Pilot and the Transportation Electrification Portfolio Balancing Account ("TEPBA"), SCE proposes that the recorded operation of the CRPBA Charge Ready 2 subaccount be reviewed by the Commission in SCE's annual April 1 Energy Resource Recovery Account ("ERRA") review application. This continuing review of the CRPBA for Charge Ready 2 activity in the ERRA Review proceeding will ensure that all entries to the account are stated correctly and are consistent with Commission decisions.

Because the Commission will perform a full review of the scope of Charge Ready 2 activities and the forecast costs in this proceeding, reasonableness review of the CRPBA should be limited to a review to ensure that all entries to the account are stated correctly and are associated with Charge Ready 2 activities as defined and approved by the Commission.

3. Rate Impacts

The following table compares SCE’s June 2018 average rates, by customer group, to an estimate of proposed average rates if SCE’s revenue requirement and revenue allocation proposal for Charge Ready 2 is approved by the Commission.

VII.

STATUTORY AND REGULATORY REQUIREMENTS

A. Statutory and Other Authority – Rule 2.1

This application is made pursuant to Commissioner Peterman’s ACR,⁵ D.16-01-023,⁶ the Commission’s Rules of Practice and Procedure, and the California Public Utilities Code.

SCE’s request complies with the Commission’s Rules of Practice and Procedure Rules 1.5 through 1.11 and 1.13, which specify the procedures for, among other things, filing documents. In addition, this request complies with Rules 2.1, 2.2 and 3.2.

Rule 2.1 requires that all applications: (1) clearly and concisely state authority or relief sought; (2) cite the statutory or other authority under which that relief is sought; and (3) be verified by the applicant. Rule 2.1 sets forth further requirements that are addressed separately below.

The relief being sought is summarized above in Sections II (Summary of SCE's Requests) and Section IV (Executive Summary), and is further described in the testimony (Exhibit SCE-1) supporting this application.

The statutory and other authority for this request includes, but is not limited to, California Public Utilities Code Sections 451, 454, 454.3, 491, 701, 702, 728, 729, Article 2 and Rule 3.2 of the Commission's Rules of Practice and Procedure, and prior decisions, orders, and resolutions of this Commission.

SCE's application has been verified by an SCE officer as provided in Rules 1.11 and 2.1.

B. Legal Name and Correspondence

Pursuant to Rule 2.1 of the Commission's Rules of Practice and Procedure, the full legal name of the applicant is Southern California Edison Company ("SCE"). SCE is a corporation organized and existing under the laws of the State of California, and is primarily engaged in the business of generating, purchasing, transmitting, distributing and selling electric energy for light, heat and power in portions of central and southern California as a public utility subject to the jurisdiction of the California Public Utilities Commission. SCE's properties, which are located primarily within the State of California, consist mainly of hydroelectric and thermal electric generating plants, together with transmission and distribution lines and other property necessary in connection with its business.

C. Proposed Categorization, Need for Hearings, Issues To Be Considered, Proposed Schedule, and Relevant Safety Considerations — Rule 2.1(c)

Commission Rule 2.1(c) requires that all applications shall state “the proposed category for the proceeding, the need for hearing, the issues to be considered including relevant safety considerations, and a proposed schedule.”

1. Proposed Category

Rule 1.3(e) of the Commission's Rules of Practice and Procedure defines “ratesetting” proceedings as “proceedings in which the Commission sets or investigates rates for a specifically named utility (or utilities), or establishes a mechanism that in turn sets the rates for a specifically named utility (or utilities).” This application will include the setting and investigation of rates, and includes SCE's proposal for a “mechanism” that will influence the setting of rates in future applications. Therefore, for purposes of Rule 2.1, SCE proposes that this proceeding be categorized as ratesetting.

2. Need for Hearings

The need for hearings in this proceeding, and the issues to be considered in such hearings, will depend in large part on the degree to which other parties contest SCE's request. SCE's proposed procedural schedule below assumes evidentiary hearings will be held; however, the need for hearings will be determined by the assigned Administrative Law Judge(s).

3. Issues to be Considered, Including Relevant Safety Considerations

The primary issue to be considered in this proceeding is the reasonableness of SCE's Charge Ready 2 programs as described in Sections II (Summary of SCE's Requests) and Section IV (Executive Summary) above and in more detail in SCE's supporting testimony served concurrently with this application. D.16-01-017 approved an amendment to Rule 2.1(c) of the Commission's Rules of Practice and Procedure (Title 20, Division 1, of the California Code of Regulations) to require all applications to identify all relevant safety considerations implicated by the application. One of SCE's core values is to protect public and employee safety. All electric infrastructure installed and operated by SCE as part of its Charge Ready 2 programs will follow SCE Transmission & Distribution's standard operating procedures to ensure safety. Additionally, this infrastructure will adhere to applicable technical standards and energy efficiency recommendations. For any electric installations on the customer side of the meter as part of Charge Ready 2, SCE will use, and require participating customers to use, a properly-licensed electrical contractor. All SCE make-ready infrastructure in Charge Ready 2 will be installed by SCE employees or IBEW signatory contractors. Furthermore, all installations, whether made by SCE or participating customers, will require appropriate permitting and inspection in compliance with applicable codes and ordinances.

4. Procedural Schedule

The primary issue to be considered in this proceeding is the reasonableness of SCE's Charge Ready 2 proposal, including ratemaking. To allow the Commission to issue a timely final decision in this proceeding, SCE respectfully requests that the Commission process the present application according to the following schedule:

The presently effective rates and the illustrative changes proposed to be made to those rates are discussed in this application in Section C.3, as well as SCE's supporting testimony served concurrently with this application, use rates current as of June 2018. The proposed rates are illustrative and will be updated consistent with the Commission's decision in this proceeding to reflect SCE's then-current authorized revenues when such rates are implemented. SCE's current rates and charges for electric service are in its electric tariffs and schedules on file with the Commission. These tariffs and schedules are filed with and made effective by the Commission in its decisions, orders, resolutions, and approvals of advice letter filings pursuant to Commission General Order 96-A. SCE is not requesting a general revenue increase over one percent in this application.

G. Description of SCE's Service Territory and Utility System – Rule 3.2(a)(4)

Because this application is not a general rate case application, this requirement is not applicable.

H. Summary of Earnings – Rule 3.2(a)(5)

Pursuant to Rule 3.2(c), notice will be published in a newspaper of general circulation in each county in SCE’s service territory within which the rate changes would be effective. The cities and counties affected by the rate increase proposed in this application are shown in Appendix C hereto.

Finally, pursuant to Rule 3.2(d), notice will be furnished to customers affected by the potential rate changes proposed in this application by including such notice with the regular bills mailed to those customers and by electronically linking to such notice for customer that receive their bills electronically.
