To all parties to I.19-06-014, the Commission's Safety Culture proceeding on Southern California Gas Company:

The Order Instituting Investigation in this case states the following:

"We hereby authorize SED to retain the services of an expert consultant(s) to assist it in this investigation and reporting. SoCalGas shall contract with a consultant selected by SED. The consultant shall report to and act at the sole direction of SED. SoCalGas shall pay for the consultant's services."

If any party is aware of consultants they believe may possess expertise, they shall forward the name and contact information of such consultant to Carolina.Contreras@cpuc.ca.gov, with an email copy to the service list for this proceeding. Forwarding such consultant information in no way assures that the consultant is qualified or will be hired, but it expands the potential pool of candidates. All

candidates will be required to meet strict conflict of interest and other requirements at the time of bidding and contracting.

Any party wishing to forward such consultant information shall do so no later than October 30, 2019, copying the service list for this proceeding.

The Commission's Docket Office shall file this ruling.
