Dear ALJ Robert Mason:

On Friday, December 20, 2019, Kate Toran, SFMTA Director of Taxis and Accessible Service, copied the full service list in this matter on a request that you modify your December 19th ruling (ordering comments on a wide range of questions regarding autonomous vehicle regulation) to extend time for response to a single consolidated date of February 28, 2020 (“Original SFMTA Proposal”). The Silicon Valley Leadership Group (SVLG) asked the SFMTA to follow the process outlined in CPUC Rule 11.6. This message follows up on your December 23rd email directing the SFMTA to consult with the other parties regarding its request for extension of time to file comments.

I spoke with Peter Leroe-Munoz (Counsel for the SVLG) on December 24th, and he agreed to a one week extension of time for each of the original dates in your proposed order so that comments would be due on **January 20** and **January 31** (“SVLG proposal”). In light of the Silicon Valley Leadership Group response, the SFMTA authorized me to suggest an earlier date for consolidated response of **February 21, 2020** (“Revised SFMTA Proposal”). I circulated the Revised SFMTA Proposal to the members of the service list who are parties on December 24th (see the email below). Many parties on the service list have not responded either to Ms. Toran’s initial message or to my subsequent message. This summarizes the views of the parties who responded to one of both messages:
