**ADMINISTRATIVE LAW JUDGE'S RULING  
MODIFYING PROCEEDING SCHEDULE**

This ruling modifies the proceeding schedule for Working Group Three. Accordingly, Working Group Three, established to work on portfolio optimization issues, will file and serve the Working Group Three Final Report on February 21, 2020. The modified proceeding schedule is provided in Section 2 of this ruling.

**1. Background**

The February 1, 2019 Phase 2 Scoping Memo and Ruling of Assigned Commissioner set forth the scope and schedule for three working groups. Accordingly, Working Group Three, established to work on portfolio optimization issues, was directed to file and serve the Working Group Three Final Report on January 30, 2020. Southern California Edison Company (SCE), the California Community Choice Association (CalCCA), and Commercial Energy (Commercial) are co-chairs of Working Group Three.

On January 3, 2020, SCE, CalCCA and Commercial filed a motion for additional comment opportunity and to extend time to request evidentiary hearings related to Working Group Three Final Report. The January 15, 2020

Administrative Law Judge (ALJ) Atamturk' s Ruling Modifying Proceeding Schedule granted the motion.

On January 17, 2020, the co-chairs sent ALJ Atamturk and the service list for Rulemaking (R.) 17-06-026 an email request for additional changes to the proceeding schedule. The co-chairs request additional time to prepare the final report. The co-chairs also think that parties will benefit from additional time to prepare opening and reply comments.

In the email request, SCE, CalCCA and Commercial note that the co-chairs emailed parties on January 16, 2019, concerning the proposed modifications to the proceeding schedule. The co-chairs report that parties did not oppose the requested changes to the proceeding schedule.
