**Subject:** R.19-11-009\_E-Mail Ruling Modifying Track 2 Schedule For LCR and FCR Issues

To All Parties:

The Scoping Memo and Ruling, issued on January 22, 2020, incorporated the following schedule for Track 2 pertaining to Flexible Capacity Requirement (FCR) and Local Capacity Requirement (LCR) issues:

Reply Comments on 2021 LCR and FCR Report	May 13, 2020

On March 25, the CAISO filed a motion to adjust the Track 2 schedule for LCR and FCR issues. The CAISO stated that “[d]ue to factors outside of the CAISO’s control, the CAISO will not be able to provide the draft LCR by April 1, 2020 nor the final FCR by May 1, 2020.” In its proposed Track 2 schedule, the CAISO states that the draft 2021 LCR Report will be filed on April 10, the final 2021 LCR Report will be filed on May 1, and the final 2021 FCR Report will be filed on May 15.

Because the final FCR Report will not be filed until May 15, the FCR Report cannot be timely incorporated into the Track 2 proposed decision, expected to be issued by late May, and it is necessary to issue a separate decision on the FCR Report. To issue a decision on the FCR Report as soon as practicable, the Track 2 schedule is modified to shorten time for comments on the FCR Report and reply comments on the FCR Report will no longer be filed. The Track 2 schedule for FCR and LCR issues is modified as follows. All other dates remain unchanged.
