Dear Members of the A.19-10-012 Service List:

This ruling directs San Diego Gas & Electric Company (SDG&E) to provide information and conduct outreach on the Power Your Drive Pilot (PYD Pilot) program's interest list. SDG&E seeks authorization to extend the PYD Pilot through the instant proceeding. SDG&E asserts that a second phase or extension of the PYD Pilot is necessary given existing customer demand for charging infrastructure at multi-unit dwellings (MUDs) and workplaces exceeded the size of the pilot. Because the instant application requests an extension of the PYD Pilot, it will be beneficial for parties in this proceeding to have more information about site-host/customer demand from the PYD Pilot interest list.

SDG&E shall conduct outreach to site-hosts on the PYD Pilot interest list and answer the following questions:

- 1. How many potential site-hosts are on the PYD Pilot interest list?
 - a. How many are MUDs?
 - b. How many are workplaces?

- c. How many potential site-hosts confirmed that they want to stay on the interest list?
- d. How many potential site-hosts responded that they are no longer interested in participating in the program?
- e. How many potential site-hosts did not respond to SDG&E's outreach?
- f. Describe the process to remove a site-host from the PYD Pilot interest list
- g. What, if any, explanations were provided by MUDs who asked to be removed from the Interest List?
- h. What, if any, explanations were provided by workplaces who asked to be removed from the Interest List?
- 2. How many potential site-hosts are located in a Disadvantaged Community? (See A.19-10-012 at footnote 6)
 - a. How many are MUDs?
 - b. How many are Workplaces?

In addition to its outreach efforts, SDG&E shall provide answers to the following questions:

- 3. What is the process for a site-host to request to be added to the PYD Pilot interest list?
- 4. How many charge ports (total and per site-host) are requested?
- 5. How long (i.e. average number of weeks or months for MUDs and Workplaces) have potential site-hosts spent on the PYD Pilot interest list?
- 6. How many site assessments has SDG&E performed for sites on the PYD Pilot interest list?
 - a. What, if any, information did SDG&E require from potential site-hosts before placing them on the PYD Pilot interest list?
 - b. Does SDG&E require any form of commitment (e.g. payment, performance metric, etc.) from the potential site-host to be added to the interest list?
 - i. If yes, please explain what type of commitment?
 - c. Is there any penalty attached to dropping off the interest list?

SDG&E may file its response in table or excel form, to succinctly demonstrate the information collected from its outreach efforts. SDG&E shall file its response by July 20, 2020, two-weeks prior to the start of evidentiary hearings in this proceeding.
