I. INTRODUCTION

Pursuant to Administrative Law Judge ("ALJ") McKinney's June 30, 2020 Email Ruling Updating Proceeding Schedule ("Ruling") issued in the above-referenced consolidated California Public Utilities Commission ("CPUC" or "Commission") dockets, San Diego Gas & Electric Company ("SDG&E"), the Public Advocates Office at the CPUC ("Cal Advocates"), Utility Consumers' Action Network ("UCAN"), Federal Executive Agencies ("FEA"), California Farm Bureau Federation ("Farm Bureau"), City of San Diego (the "City"), San Diego Airport Parking Company ("SDAP"), Small Business Utility Advocates ("SBUA"), Solar Energy Industries Association ("SEIA"), Energy Producers and

Users Coalition ("EPUC"), California Large Energy Consumers Association ("CLECA"), California City County Street Light Association ("CalSLA"), the California Solar & Storage Association, OhmConnect, Inc., The Utility Reform Network ("TURN"), San Diego Public School Coalition, the City of San Diego, and Enel X North America, Inc. ("Enel X") (collectively, the "Joint Statement Parties") hereby submit their Joint Status Conference Statement.

II. DISCUSSION

Per the Ruling, SDG&E was "directed to coordinate with other parties to prepare the Joint Status Conference Statement," which should address the following topics:

- 1. Status of settlement talks;
- 2. Joint stipulations of fact;
- 3. Cross-examination estimates and proposed witness schedule; and
- 4. List of exhibits for each party (including cross-examination exhibits and excluding impeachment exhibits (if any)). The exhibit list should note whether parties are prepared to stipulate to admission of the exhibit.

SDG&E hosted a teleconference on August 3, 2020, at 3:00 p.m., for all parties on the Commission's official service list in the above-captioned consolidated proceeding, to continue ongoing confidential settlement discussions pursuant to Commission Rule 12.6. At the end of the settlement discussions, SDG&E requested input from the participating parties consistent with the Ruling. The undersigned Joint Statement Parties either directly participated in the teleconference and/or communicated with participating parties following the call.

Discussion Topic 1: Status of Settlement Talks

On July 30, 2020, SDG&E moved for a one-month extension of time for hearings, in part to continue settlement discussions. Pursuant to the ALJ's August 3, 2020 email to the service list, evidentiary hearings are tentatively rescheduled for September 28 through October 2, 2020. The Joint Statement Parties have been engaged in productive settlement negotiations and believe that additional negotiations may result in the settlement of a significant number of issues in this proceeding before September 28, 2020.

Discussion Topics 2 through 4

For the reasons stated above regarding the status of settlement talks, the Joint Statement Parties agree that it would be premature and speculative to address the Ruling's Discussion Topics two through four at this time. The Joint Statement Parties recognize their potential benefits, however, and request to reserve the right to revisit the processes identified in Discussion Topics 2 through 4 until a later date, after September 14, 2020, to determine their usefulness and need in this proceeding.

III. CONCLUSION

In conclusion, the Joint Statement Parties hereby submit this Joint Status Conference Statement and look forward to the Status Conference scheduled for August 10, 2020.
