**ADMINISTRATIVE LAW JUDGE'S RULING GRANTING MOTION OF THE
CONSUMER PROTECTION AND ENFORCEMENT DIVISION,
TRANSPORTATION ENFORCEMENT BRANCH, TO FILE ITS CONFIDENTIAL
COMPLIANCE FILING UNDER SEAL**

On August 17, 2020, the Transportation Enforcement Branch (TEB) of the Consumer Protection and Enforcement Division (CPED) of the California Public Utilities Commission (Commission) tendered its compliance filing pursuant to Resolution ALJ-377 (formerly ALJ-299). On the same date, TEB moved to file under seal its compliance filing.

We grant TEB's Motion to File under Seal. The compliance filing includes Citation No. F-5687 issued on June 17, 2020, which is the subject of an appeal and the current motion. Citation F-5687 includes four attachments. Attachment #4 contains copies of "waybills" which documented passenger names and addresses. Waybills must include, among other items, the name and address of the person requesting or arranging the charter. TEB requested Leave to file its Confidential Compliance Under Seal in order to protect such passenger

information. Pursuant to GO 66-D, section 3.4 passenger information falls within the confidential matrices as established by the Commission.

IT IS RULED that:

1. The Compliance Filing includes Citation No. F-5687 issued on June 17, 2020 by TEB.

2. Attachment #4 of Citation No. F-5687 includes passenger information, which has been deemed confidential under
General Order 66-D.

The Motion of TEB for leave to file its Compliance Filing under seal is granted.
