A.20-04-013: Email Ruling Updating Proceeding Agenda and Providing Guidance to Parties

The evidentiary hearing tentatively scheduled for September 21, 2020 in the Scoping Memo is canceled to provide additional time for parties to resolve issues prior to scheduling evidentiary hearings. Additionally, the Commission needs additional time to put in place the technical support for a Webex-based evidentiary hearing in this proceeding.

An updated proceeding schedule is below. If parties are unable to reach a Settlement Agreement by September 30, 2020, they may: (1) request additional time to attempt to reach a Settlement Agreement; or, (2) Provide a proposed schedule to move to evidentiary hearings. A subsequent email ruling will provide additional guidance regarding path (2).
