Attention all Parties to Proceeding Number A.20-08-002:

This ruling supersedes the prior email ruling, issued on November 25, 2020 at 8:22 a.m.

On November 23, 2020, Sierra Club filed a motion for reconsideration of the denial of the joint request to suspend the filling of all intervenor testimony. After reviewing the additional information provided, the motion for reconsideration is granted. The filing of intervenor testimony along with other dates in the hearing schedule are temporarily suspended.

Two weeks following the issuance of a final decision in A.19-08-002, the parties shall file an amended joint case management statement regarding adjustments to the schedule brought about by the filing of the supplemental testimony and the need for any interim orders. A Pre-Hearing Conference to revise hearing timelines will be scheduled shortly thereafter, if necessary.
