This email ruling directs EarthGrid PBC (EarthGrid) to file and serve evidence demonstrating that it possesses:

- 1. A minimum of \$100,000 of cash or cash equivalent, pursuant to the requirements of D.95-12-056, as demonstration of financial fitness; and
- 2. A minimum of \$25,000 of cash or cash equivalent, which is equal to the potential cost of deposits as stated in EarthGrid's application.

Unaudited financial statements will not be accepted, nor will any financial instruments that can only be liquidated if EarthGrid has exhausted all other funding sources (e.g., surety bonds). Acceptable forms of financial documentation are:

- 1. Cash or cash equivalent, including cashier's check, sight draft, performance bond proceeds, or traveler's checks;
- 2. Certificate of deposit or other liquid deposit, with a reputable bank or other financial institution;

- 3. Preferred stock proceeds or other corporate shareholder equity, provided that use is restricted to maintenance of working capital for a period of at least 12 months beyond certification of the applicant by the Commission;
- Letter of credit; issued by a reputable bank or other financial institution, irrevocable for a period of at least 12 months beyond certification of the applicant by the Commission;
- 5. Line of credit or other loan, issued by a reputable bank or other financial institution irrevocable for a period of at least 12 months beyond certification of the applicant by the Commission, and payable on an interest-only basis for the same period;
- 6. Loan, issued by a qualified subsidiary, affiliate, or a qualified irrevocable for a period of at least 12 months beyond certification of the applicant by the Commission, and payable on an interest-only basis for the same period;
- Guarantee, issued by a corporation, partnership, or other person or association, irrevocable for a period of at least 12 months beyond certification of the applicant by the Commission; or
- 8. Guarantee, issued by a subsidiary, affiliate or corporation holding a controlling interest in the applicant irrevocable for a period of at least 12 months beyond certification of the applicant by the Commission.

The filing is due on March 3, 2021.
