Upon stipulation of all parties to a 10-day comment period on the proposed decision in this case, the procedural schedule is modified as shown below.

## Background

On September 30, 2020, Pacific Gas and Electric Company (PG&E) filed an application requesting California Public Utilities Commission (Commission) approval to sell its San Francisco General Office Complex (SFGO) pursuant to Section 851 of the California Public Utilities Code, to distribute the gain to customers, and to recover associated costs related to the relocation of its corporate headquarters to the Lakeside Building in Oakland. The scoping memo for the proceeding allowed PG&E to select between two alternative schedules for the proceeding. PG&E proposed dates for the remainder of this proceeding according to the "Alternative 2" schedule in a case management statement, dated May 24, 2021.

#### Discussion

Adoption of the Alternative 2 schedule requires all parties to stipulate to a reduced (10-day) comment period on the proposed decision. The parties stipulated to the 10-day shortened comment period by email, dated May 26, 2021. Upon review, we find the proposed dates reasonable and in alignment with the Alternative 2 schedule provided in the scoping memo. Accordingly, the procedural schedule for the remainder of this proceeding is set as follows:
