**Subject:** A.19-11-019: Email Ruling Denying Without Prejudice Motion Seeking Transcript Corrections

Dear members of the A.19-11-019 service list:

This email ruling denies, without prejudice, the motion of Pacific Gas and Electric Company (PG&E) for corrections to the hearing transcript.

PG&E's requested corrections are voluminous, and do not appear to materially affect the record of the proceeding in most instances. In light of the nature of the motion, constrained Commission resources, and the need to timely draft a complex proposed decision in this phase of the proceeding, the motion is denied without prejudice.

To the extent PG&E seeks corrections to the transcript that are material to litigated matters in this proceeding, PG&E is encouraged to resubmit its motion seeking only such material corrections. If it so chooses, PG&E must do so no later than July 9, 2021.

IT IS SO RULED.
