ADMINISTRATIVE LAW JUDGE'S RULING ALLOWING PARTIES IN RULEMAKING 05-06-040 TO FILE COMMENTS ON PROPOSED DECISION AND ALTERNATE PROPOSED DECISION ISSUED IN RULEMAKING 18-07-003

Today's ruling allows parties to Rulemaking (R.) 05-06-040 to file comments on the Proposed Decision (PD) and the Alternate Proposed Decision (APD) clarifying and improving confidentiality rules for the Renewables Portfolio Standard (RPS) Program in R.18-07-003.

On September 16, 2021, pursuant to Public Utilities Code § 311(e), we served upon all parties in R.18-07-003 the PD and APD. The PD and APD are proposing modifications to confidentiality rules for RPS data adopted in R.05-06-040 via Decision 06-06-066. However, the PD and APD were not served

on the R.05-06-040 service list. With this ruling, we extend an opportunity to parties in R.05-06-040 to file comments and replies.

To ensure that we give parties in both proceedings the same amount of time to comment, parties to R.18-07-003 may file comments per the original comment due date of October 6, 2021, and replies by October 11, 2021.

Parties to R.05-06-040, who are not parties to R.18-07-003, may file comments on the PD and APD by October 20, 2021, and reply comments by October 25, 2021 responding to any comments filed on October 6, 2021 and October 20, 2021.

Parties to R.18-07-003 may also file additional reply comments by October 25, 2021 limited to responding to the October 20, 2021 comments.
