A.21-09-001 Email Ruling Noticing October 28, 2021 Telephonic Prehearing Conference

Today's email ruling sets the schedule for a telephonic prehearing conference (PHC) in the Application (A.) 21-09-001, Application of San Diego Gas & Electric Company (U 902 M) to Update Rate Design to Include a Residential Untiered Time-of-Use Rate with a Fixed Charge.

The telephonic PHC is scheduled for Thursday, October 28, 2021, at 10:00 a.m. The call-in details are as follows:

Please call-in 15 minutes before the start time to allow sufficient time to prepare and start promptly at 10:00 a.m.

PHC Tentative Agenda: The purpose of this PHC is to discuss the scope, schedule, and categorization for the proceeding and the need for evidentiary hearing. The discussion will be used to develop the Assigned Commissioner's Scoping Memo for the proceeding.

Prior to the prehearing conference, I will circulate a list of proposed scoping issues and a proposed schedule.

The tentative agenda of the PHC is as follows:

1. Introduction and Ground Rules
2. Appearances
3. Categorization of Proceeding
4. Scope of Issues
5. Need for Hearings
6. Schedule

PHC Participation: Parties wanting to participate verbally at the PHC shall send an email to me no later than October 21, 2021. The subject line of the email shall include "A.21-09-001 PHC Party Representative" and the contents of the email shall include the name of the party and the name of the representative who will participate verbally at the PHC. Only one representative for each party will be permitted to speak during the PHC. Parties shall provide any prepared statement they intent to make during the PHC via email to the court reporter before or on the day of the PHC.

PHC Transcripts: Parties seeking expedited transcripts should advise the Chief Hearing Reporter via e-mail at reporting@cpuc.ca.gov, no later than three days prior to the PHC. Please contact the Hearing Calendar Clerk at (415) 703-1203 if parties have any questions about the hearing date, time, or dial-in information.

Ground Rules: Because this prehearing conference is being held telephonically, it is not possible to see raised hands to know when participants want to speak. Further, the prehearing conference is on the record and a court reporter will transcribe the discussion for the official transcript. As such, the court reporter will interrupt a speaker (when possible to do so without disruption) when there is/are inaudible statement(s) or portions thereof. When disruption is not possible, the reporter will insert the word "inaudible" in the transcript when there is dropped, garbled, or otherwise indecipherable audio. Neither of these conditions are optimal. To limit these conditions, and ensure everyone is heard and the court reporter accurately transcribes the discussion, participants shall adhere to the following rules:

1. All participants will mute their phones when not speaking.
2. Only one representative of an entity, as indicated by the required email discussed above, will be permitted to speak during the telephonic prehearing conference.

3. Speakers will only speak when prompted by the Administrative Law Judge.
4. Speakers will identify themselves when they begin to speak.
5. Speakers will proceed slowly and over enunciate.
6. Speakers will indicate when they have concluded.

Motions: For the ease of the court reporter, no motions will be ruled upon during the prehearing conference. All motions must be filed prior to or following the PHC.

IT IS RULED that

1. The prehearing conference for Application 21-09-001 is scheduled for October 28, 2021, beginning at 10:00 a.m. and will be held telephonically, as described in this Email Ruling.
2. Parties and other entities wanting to participate in the telephonic prehearing conference shall send an email to the assigned Administrative Law Judge as instructed in this Email Ruling.
3. Parties shall adhere to the ground rules provided in this Email Ruling.
