WHEREAS, selected high-income neighborhoods and cities receive optical fiber with speeds over 100 times faster, or up to 1 Gbps (1000 Mbps); and

WHEREAS, the California Public Utilities Commission (“CPUC”) opened a proceeding, Rulemaking (R.) 20-09-001 and is gathering evidence, data, and testimony regarding Telecommunications and Internet Service Providers in California; and

WHEREAS, California broadband providers have avoided regulatory oversight of access, affordability, and the reliability of high-speed internet, to the detriment of rural communities and low-income inner-city neighborhoods; and





Central Valley Leadership Round Table

For California Public Utilities Commission Proceeding R.20-09-001

The Central Valley Leadership Round Table (CVLRT) is comprised of elected representatives, educators, community advocates and residents of Fresno, Tulare, Kings and Merced Counties. CVLRT reflects the shared interests, aspirations, and dreams of working and poor communities of the Valley, between the Sierra Nevadas and the San Luis Rey Water Project and from Sacramento to the Tehachapi Mountains.

Governor Newsom, the California Legislature, the California Public Utilities Commission, the California Broadband Council, the California Department of Technology, the Broadband and Digital Literacy Office and various agencies and functionaries are entrusted with the mission to end the “Digital Divide” and “establish 98% high speed internet and 90% statewide adoption by 2023.”

The CVLRT salutes the efforts by the offices of the Governor and the California Public Utilities Commission to establish a new era of accountability and regulatory oversight of all forms of communications and broadband. However, the public is only beginning to learn of the large infusions of public funds which are in motion. Target communities have been identified, fiber network routes defined, and a non-governmental agency has formed a Limited Liability Corporation to oversee the funding allocations.

However, the current phase of infrastructure planning, the proposed middle mile network and framework for the distribution of funds have left many Central Valley communities behind. As a result, the Central Valley Leadership Round Table is submitting Resolutions in Support of Broadband Infrastructure and inclusion in the proposed Open Access Middle Mile Fiber Network.

The Resolutions have been adopted by the City Councils of Firebaugh, Huron, and Mendota. An identical Resolution is scheduled for consideration of the San Joaquin City Council at their next meeting. The adopted resolutions are attached along with a letter of support from the City Manager of San Joaquin.

Firebaugh, Huron, Mendota, San Joaquin and the unincorporated City of Tranquility lie along rural routes in close proximity to each other and the proposed Middle Mile Fiber Network. These

City Councils are supporting this joint action as an appeal for the development of Broadband Infrastructure in their respective communities. Together they represent 6,843 households with approximately 27,663 residents (*U.S. Census*).

Like many parts of the Central Valley, rural neighborhoods in west Fresno County suffered disproportionate impacts from COVID-19. Infections struck the homes of those who worked in the fields and processing plants with higher frequency. They risked their health, and, in many cases, their lives to feed their families and provide essential products for the nation.

The pandemic revealed the shortcomings of County health services, messaging, worker protections, and the institutions which are supposed to provide a safety net for rural families. The failures of online education demonstrated the lack of access to high-speed internet in many communities. These communities are determined not to return to the pre-pandemic status quo.

As per the Resolution, “California broadband providers have avoided regulatory oversight of access, affordability, and the reliability of high-speed internet, to the detriment of rural communities and low-income, inner-city neighborhoods.”

Also, “elected leaders must advocate for rural and inner-city residents and their access to vital services, including health, education, social service, personal development, civic participation and inclusion in society, which rely increasingly on the internet.”

Each City declares support for the CPUC proceeding, Rulemaking (R.) 20-09-001, and regulatory oversight of Telecommunications and Internet Service Providers. They support a preference for fiber, particularly for all new housing developments, and the concept of Universal Service to be applied to Broadband.

The Resolution also calls for the public funds to go to employers who make every effort to hire a local workforce and provide good wages, benefits, training, safety programs and job security. They must commit to support a career path and permanent employment in the industry.

The Resolution ends with a declaration of support for the proposed West Fresno County Fiber Network, which would span approximately 50 miles and could connect to the Governor’s proposed Middle Mile Network in the north at Dos Palos, and in the south near Kerman, at CA 145 and Manning Ave.

The Central Valley Leadership Round Table intends to expand its efforts to garner adoption of the Resolution in Support of Broadband Infrastructure in more communities in east and west Fresno County and surrounding areas. The CVLRT considers this a fair and equitable initiative which should receive support from all elected representatives and serious consideration by the pertinent State agencies.
