**ADMINISTRATIVE LAW JUDGE'S RULING  
RESETTING PUBLIC PARTICIPATION HEARING**

**1. March 24, 2022, Public Participation Hearing**

I issued a ruling on December 16, 2021, scheduling a Public Participation Hearing (PPH) for San Jose Water for Application (A.) 21-05-004 for February 24, 2022, at 6:00 p.m. The ruling also requires San Jose Water: 1) to obtain the Public Advisor's Office's approval of a notice of that hearing date, 2) deliver that notice by bill insert to its customers, and 3) verify its compliance with notice requirements at least five days prior to the PPH.

By an electronic message to me on December 20, 2021, served on all parties to this consolidated proceeding, counsel for San Jose Water informed every one of the timing problem related to the bimonthly billing cycle used by San Jose Water such that a period of close to 60 days is required to complete the billing cycle. On December 21, 2021, I informed San Jose Water's counsel, with a copy to all parties to this consolidated proceeding, that March 24, 2022, is available as a date on which the PPH for A.21-05-004 might be rescheduled.

On December 21, 2021, San Jose Water Company filed a motion seeking to reschedule the PPH so that it can meet all three of the requirements for a PPH set forth in the December 16, 2021, ruling. San Jose Water requested that the PPH for A.21-05-004 be rescheduled for March 24, 2021.

Accordingly, the PPH for San Jose Water Company for A.21-05-004, is now scheduled for March 24, 2022, at 6 p.m.
