ADMINISTRATIVE LAW JUDGE'S RULING ADMITTING EXHIBITS INTO EVIDENCE AND GRANTING REQUESTS FOR CONFIDENTIAL TREATMENT

On October 8, 2021, a status conference was held in this proceeding.

At the status conference, Exhibits PGE-1, PGE-1C, PGE-2, PGE-2C, PGE-3,

and Exhibits JCCA-01, and JCCA-01C were admitted into evidence.

On October 18, 2021, Pacific Gas and Electric Company (PG&E) and the Joint CCAs¹ filed two motions. The first joint motion requested that the Commission issue an order granting confidential treatment to certain information identified by gray shading in the confidential versions of Exhibit JCCA-01C, and Exhibits PGE-1C and PGE-2C. The second joint motion requested that Exhibits PGE-1C, PGE-2C, PGE-4, JCCA-01C, JCCA-02, JCCA-03, JCCA-04, JCCA-05 and JCCA-06 be admitted into evidence.

¹ The Joint Community Choice Aggregators (CCAs) include Central Coast Community Energy, City and County of San Francisco, East Bay Community Energy, Marin Clean Energy, Peninsula Clean Energy Authority, Pioneer Community Energy, San Jose Clean Energy, Silicon Valley Clean Energy Authority, and Sonoma Clean Power.

On October 22, 2021, the Joint CCAs filed a motion for leave to file a confidential version of their Opening Brief under seal.

On November 18, 2021, PG&E filed a motion to admit Exhibits PGE-5, PGE-5C and PGE-6 into evidence. On November 18, 2021, PG&E also filed a separate motion requesting confidential treatment of the material in gray shading in the confidential version of Exhibit PGE-5C.

On November 18, 2021, the Joint CCAs filed a motion to admit Exhibits JCCA-07, JCCA-08 and JCCA-09 into evidence.

On December 17, 2021, PG&E filed a motion to admit Exhibits PGE-7 and PGE-8 into evidence.

On January 6, 2021, PG&E filed a motion to admit PGE-9, PGE-9C, PGE-10 and PGE-11 into evidence. Also, on January 6, 2021, PG&E filed a separate motion requesting confidential treatment of the material in gray shading in the confidential version of Exhibit PGE-9C.

All motions requesting confidential treatment were filed pursuant to various Commission Decisions, Rules, Codes and General Orders (GOs). These motions are unopposed.

By Decision (D.) 06-06-066, D.08-04-023 and D.14-10-033, the Commission sets forth guidelines for confidential information as it applies to the confidentiality of electric procurement and market sensitive greenhouse gas data submitted to the Commission. GO 66-C addresses access to records in the Commission's possession. Pub. Util. Code § 454.5(g) generally addresses the Commission's processes regarding confidentiality, while Rule 11.5 addresses sealing all or part of an evidentiary record.

Certain information submitted throughout the proceeding included market sensitive electric procurement-related information deserving protection from public view. Portions of Exhibits PGE-1C, PGE-2C, PGE-5C, PGE-9C,
