Pursuant to the Administrative Law Judges' (ALJ) March 15, 2022 Ruling Requiring Weekly Progress Reports (March 15 Ruling), Safety and Enforcement Division (SED) files this weekly status update.<sup>1</sup>

As reported in SED's April 8, 2022, April 15, 2022, April 22, 2022, April 29, 2022, and May 6 Progress Reports, SED has completed review of all of the emails received from the Commission, and found no documents that were responsive to the Administrative Law Judges' (ALJ) *Ruling Requiring an Expanded Document Search*, dated February 2, 2022, or the ALJs' *Ruling Addressing Two Motions to Compel*, dated November 29, 2021. On April 11, 2022, the ALJs issued a ruling addressing various motions and setting a briefing schedule.<sup>2</sup> The April 11 Ruling references SED's document search, but does not rule on SED's *Motion for Guidance*, filed March 25, 2022.

Pursuant to the information provided in General Counsel's March 22, 2022 email, no further searches have been conducted. SED awaits a ruling on the *Motion for Guidance*.
