ADMINISTRATIVE LAW JUDGES' RULING NOTICING ORAL ARGUMENT

The Protect Our Community Foundation (PCF) requested oral argument before the Commission on March 11, 2022, the same day it filed its opening brief, pursuant to Public Utilities Code § 1701.3(i) and Rule 13.14(b) of the Commission's Rules of Practice and Procedure. This ruling notices the oral argument in the above-captioned proceedings before a quorum of the Commission and Administrative Law Judges (ALJs) Jessica Hecht and

Zhen Zhang as follows:

Due to the ongoing concerns and requirements regarding workplace

safety, Commissioners and all parties shall participate through video and audio

conference.

Audio/Visual Set-Up Prior to the Oral Argument

- All parties shall connect to both the video and audio connections by 11:30 a.m. on the date set for the oral argument to test their equipment and connectivity. This will also facilitate the Court Reporters' identification of speakers, and help to avoid disturbances otherwise caused by late arrivals and connection difficulties.
- We will go over preliminary matters and housekeeping issues starting at 11:45 a.m., prior to going on the record. These preliminary matters will include review of the agenda, as well as other scheduling, procedural, or preliminary housekeeping matters, as needed. This should allow for an orderly and timely commencement of the parties' arguments at 12:00 p.m.
- Since the audio connection is solely through the Verizon conference line, all parties shall connect in the following sequence:
 - 1) with your phone, connect to the Verizon conference line, and

2) on the computer, log into the Webex link.

• Parties, counsel, court reporters, the ALJs, and the Commissioners will have their video on during the oral argument and will be visible on the screen. Other

attendees do not appear on the screen and will be in a watch-only mode and muted.

- All persons logging into WebEx will enter as an attendee. The Commission staff will activate visibility for the party representatives (panelists) identified in advance (*see* instructions below).
- If needed, Commission staff will separately contact the designated speakers with specific connectivity information.
- Designated panelists will be expected to leave their camera on except during breaks.
- All attendees should mute their phone when not speaking.
- Prior to the day of the oral argument, all presenting parties shall ensure that they have all necessary audio/visual equipment, sufficient power/battery, and sufficient connectivity to participate fully.

- 4. Whether your party will be presenting jointly with, or deferring time to, another active party during the oral argument. Parties that choose to consolidate their presentations could be given additional time.

Please make all reasonable efforts to consolidate or coordinate

presentations to avoid duplication of positions.

Please note that it is unlikely that we will be able to accept handouts, slides or other demonstration items due to the remote hearing environment.
