## NOTICE OF EX PARTE COMMUNICATION OF GOODLEAP AND ENPHASE ENERGY

Pursuant to Rule 8.4 of the California Public Utilities Commission Rules of Practice and Procedure, GoodLeap and Enphase Energy hereby gives notice of an ex parte meeting in the above-captioned proceeding. The meeting took place on Wednesday, August 10, 2022 via WebEx and commenced at 2:30 PM and concluded at 3:00 PM with Winnie Chen in the office of Commissioner Rechtschaffen and Rosanne O'Hara and Kerry Fleisher in the office of President Reynolds. Attending for GoodLeap were Julia Pyper, Vice President of Communications and Policy and Delaney Hunter, Consultant to GoodLeap. Attending for Enphase Energy was Raghav Murali, J.D., Director, Policy and Government Affairs

In the meeting the parties discussed the Proposed Decision currently pending before the Commission. GoodLeap and Enphase Energy explained the roles their companies play in financing clean energy solutions such as rooftop solar, battery storage, heat pumps and electric vehicle chargers for California homeowners. GoodLeap and Enphase Energy outlined supply chain challenges facing the battery storage market in California and discussed the need for a glide path to new export rates – rather than a cliff – as a necessary part of any updated net metering tariff. They urged changes to the current Proposed Decision to remove solar-specific grid access fees and outlined jurisdictional limitations on assessing non-bypassable charges behind-the-meter. Additionally, GoodLeap and Enphase Energy urged the Commission to bring residential solar cost per watt data closer in line with the market reality and referenced, specifically, recently reported costs of solar. Lastly, GoodLeap and Enphase discussed efforts to expand the clean energy workforce as well as broader efforts to harness distributed energy technologies to provide value to the grid.
