ADMINISTRATIVE LAW JUDGE'S RULING SETTING A SITE VISIT AND A PUBLIC PARTICIPATION HEARING

On February 28, 2022, Southern California Edison Company and San Diego Gas & Electric Company (hereinafter collectively referred as the Applicants) filed this Joint Application for the 2021 Nuclear Decommissioning Cost Triennial Proceeding (NDCTP).

1. Site Tour and Visit

As part of reviewing the Application, the Commission determined that it is beneficial for staff and parties to visit and tour the San Onofre Nuclear Generating Station. The tour is set for January 9, 2023. The Applicants shall provide timely notice of the tour to the service list, which shall include all the necessary information and details for interested parties to attend.

2. Public Participation Hearing

A public participation hearing (PPH) is set for January 10, 2023, at 5:00 p.m. The purpose of the PPH is to inform and solicit comments from members of the public on the proposals the Applicants are requesting in this Application.

2.1. Presentations at the PPH

At the PPH, the Applicants shall give a presentation, not to exceed 10 minutes, to provide an overview of their requests. Parties may request to also make a presentation of their recommendations or proposals at the PPH by contacting the assigned Administrative Law Judge at least seven days before the date of the PPH and serve the request on the service list.

2.2. Public Notice

Pursuant to Rule 13.1(b) of the California Public Utilities Commission's Rule of Practice and Procedure, the Applicants shall prepare draft newspaper notice(s) to the customers taking service in their service areas and obtain the Public Advisor's Office (PAO) approval of the draft newspaper notice(s). The Applicants shall publish the approved notice in one or more local newspapers of general circulation in their service areas for seven consecutive days prior to and including the date of the PPH. The notice(s) shall include the time and date of the PPH, the website where members of the public can view the live stream of the PPH, and the call-in information for members of the public to speak at the PPH. The Applicants shall file the proof of publication and sample copies of the notices with the Commission within 10 days after publication. The Applicants shall also prominently post a notice of the PPHs on its website and in all their offices where customers come into contact with customer service representatives.

2.3. Billing Notice

The Applicants shall also prepare a draft mail notice to its customers, obtain PAO approval of the draft notice, and mail the approved notice to customers. The notice shall inform customers about the PPHs, the purpose of the PPHs, a summary of the requests in this Application, as well as the time and date of the PPH, the website where members of the public can view the live stream of the PPH, and the call-in information for members of the public to speak at the PPH. The Applicants shall provide customer notice via mailing not less than 15 days before the date of the first scheduled PPH.

IT IS RULED that:

1. The tour of the San Onofre Nuclear Generating Station is set for January 9, 2023.
2. The Applicants shall provide timely notice of the tour to the service list, which shall include all the necessary information and details for interested parties to attend.
3. The public participation hearing is set for January 10, 2023 at 5:00 p.m.
4. The Applicants shall publish the approved notice in one or more local newspapers of general circulation in their service areas for seven consecutive days prior to and including the date of the public participation hearing.
5. The Applicants shall prominently post a notice of the public participation hearing on their website and in all their offices where customers come into contact with customer service representatives.

6. The Applicants shall provide customer notice of the public participation hearing via mailing not less than 15 days before the date of the public participation hearing.
