**Subject:** A.22-05-014 E-Mail Ruling Regarding Evidentiary Hearing

The Assigned Commissioner's Scoping Memo and Ruling (1) directs the parties in this proceeding to file a joint case management statement by September 21, 2022 that states whether any party believes that an evidentiary hearing is required and (2) schedules an evidentiary hearing if needed for September 28, 2022. Southern California Edison Company filed a Case Management Statement on September 21, 2022 that states that the parties have determined that no material issues of fact exist that require an evidentiary hearing. No other case management statement was filed by a party by September 21, 2022. Because no material issues of fact that require an evidentiary hearing have been identified by the September 21, 2022 deadline, an evidentiary hearing in this proceeding is not needed, and the evidentiary hearing scheduled for September 28, 2022 is taken off-calendar.
