On September 14, 2022, Mr. Mark Schreiber informed the Service List in this proceeding that the current Representative for Bass Lake, Mr. Frank Brommenschenkel had passed away. In this email, Mr. Schreiber requested that he be granted party status so that he could act on behalf of Bass Lake in this proceeding.
