**RULING FOR DECEMBER 6, 2022 EVIDENTIARY HEARING**

A Status Conference was held on November 21, 2022. Parties appearing included Southern California Edison Company (SCE) and the Public Advocates Office of the California Public Utilities Commission (Cal Advocates).

**1. Evidentiary Hearing**

The Evidentiary Hearing will be conducted on December 6, 2022, from 9:00 a.m. to 5:00 p.m. via Webex. Counsel for SCE and Cal Advocates and the two witnesses listed below shall e-mail the assigned Administrative Law Judge at [susan.lee@cpuc.ca.gov](mailto:susan.lee@cpuc.ca.gov) and the Proceedings Analyst at [thomas.gutierrez@cpuc.ca.gov](mailto:thomas.gutierrez@cpuc.ca.gov), with a copy to the service list, of an appropriate e-mail address in order to participate as a panelist during the Evidentiary Hearing.

In a Joint Status Conference Statement served on November 17, 2022, the parties reported that there remain two unresolved issues in this proceeding: (1) whether the supplemental overtime paid to SCE salary employees for time worked over a normal eight-hour work day under emergency conditions is

incremental and reasonable to be recovered from ratepayers; and (2) whether an advice letter is needed to describe the process for refunding SCE's customers to the extent it receives insurance recovery.

At the Status Conference, Don Daigler and John Butler from SCE were determined to be the appropriate witnesses to address these two issues at the Evidentiary Hearing.

## **2. Exhibit List**

The parties are directed to file and serve an exhibit list as discussed at the Status Conference by December 2, 2022. The Evidentiary Hearing will start with identifying and entering the exhibits.

Cross exhibits shall be marked and identified in sequential numeric order following the exhibits in the exhibit list, and served by 10:00 a.m. on December 5, 2022.

5. The parties shall file the Joint Conference Statement served on November 17, 2022.
