# ADMINISTRATIVE LAW JUDGES' RULING REVISING PROCEDURAL SCHEDULE

As discussed herein, this Ruling adopts the Revised Procedural Schedule below in response to party procedural e-mail requests to modify the schedule.

On February 14, 2023, Southern California Edison Company (SCE) sent an e-mail to the Administrative Law Judges and members of the service list for the consolidated applications. In the e-mail, SCE requested changes to the procedural schedule. In response, on February 15, 2022, Coalition for Community Solar Access (CCSA), The Utility Reform Network (TURN), and Clean Coalition e-mailed the service list with varying recommendations. Copies of these e-mails are attached as Attachment 1. Each of the schedule proposals, including the current schedule, are presented in Table A below and include the proposal supporters.

#### Table A. Schedule Proposals

There are two concerns expressed by parties that require our response. First, we agree with SCE that opening briefs and reply briefs are necessary and have not been scheduled. SCE correctly points out in its e-mail that briefs, not testimony, are the appropriate vehicle to address legal arguments. Thereby, we also disagree with CCSA, that opening briefs and reply briefs would only be required if evidentiary hearings are held. Accordingly, the revised schedule we adopt below includes deadlines for filing opening briefs and reply briefs.

Second, we address related concerns expressed by CCSA and TURN regarding the need for reply or surrebuttal testimony. We find that amended testimony, rebuttal testimony, and surrebuttal testimony allows for "the development of a complete record." However, these multiple rounds of testimony may still result in disputed facts, which could require evidentiary hearings. While doubtful, the need for evidentiary hearing cannot be determined

until after the service of the three rounds of testimony. Hence, we include a deadline to request evidentiary hearing. If no evidentiary hearing is scheduled, parties will need to file motions for testimony to be entered into the record. A deadline for filing such motions is also included on the revised schedule.

Relatedly, there is a slight variation in the requested rounds of testimony. CCSA requests reply testimony and TURN requests surrebuttal testimony. We find it unnecessary to schedule both reply and surrebuttal testimony. Surrebuttal testimony provides that final opportunity to present facts in response to prior testimony. Thus, the adopted schedule indicates a deadline for serving surrebuttal testimony.

We find the following Revised Proceeding Schedule meets the needs of due process and regulatory efficiency.
