**Administrative Law Judge's Ruling
PROVIDING NOTICE OF PUBLIC ENGAGEMENT WORKSHOPS**

This ruling serves notice on the Service List in this proceeding of the following events.

The California Public Utilities Commission (Commission) and the California Department of Technology (CDT) are partnering with local and regional organizations and other state entities to host 20 Broadband for All Digital Equity and Broadband Equity, Access, and Deployment (BEAD) planning workshops throughout the state, including those listed below. The Governor designated the Commission to serve as the recipient of and administering agent for the BEAD program for California, and designated the CDT to serve as the recipient of and administering agent for the Digital Equity Plan.

These events are required by the National Telecommunications and Information Administration (NTIA) to assist in the development of a Five-Year Action Plan for BEAD funding. Consistent with Rule 7.5(a)(3) of the

Commission's Rules of Practice and Procedure,¹ these events also may provide input on the proposed rules prepared by the Commission's Communications Division Staff, upon which parties will have the opportunity to file comments.
