Pursuant to Rule 1.12 of the Rules of Practice and Procedure (“Rules”) of the California Public Utilities Commission (“Commission”), Star & Crescent Boat Company (VCC-63) (“Applicant”) submits this AMENDMENT TO APPLICATION NO. 23-05-006 (“Amendment”) to provide Exhibits B, C and D to its Application. By accompanying motion, Applicant seeks confidential treatment of the three exhibits proceeding under seal.

By its Application, Applicant requests authority to increase its base one-way passenger fare by one dollar (\$1), from \$7 to \$8 for its scheduled passenger vessel common carrier service between the City of Coronado and the City of San Diego. Applicant also seeks authorization to establish a Zone of Rate Freedom (“ZORF”) of fifteen percent (15%) above and below the proposed new baseline fare, as long as prior notice is provided to the public and the Commission at least ten (10) days prior to the effective date of the planned rate adjustment. In support of its Application, Applicant

submitted the current Fare Schedule Page in its Tariff (Exhibit A). In accordance with Rule 3.2(a)(1), Applicant also provided its most recent balance sheet (Exhibit B), as well as an income statement (Exhibit C) covering the period between Applicant's last Annual Report (Exhibit D) and the date of its most recent balance sheet (Exhibit B). Exhibit D contains additional financial data reported to the Commission in Applicant's Annual Report for 2022 (Exhibit D). Finally, Applicant submitted its Articles of Incorporation (Exhibit E).

Of the five exhibits referenced above, only Exhibits A and E were submitted with the Application. In order to facilitate review of the other exhibits (B, C and D) while preserving their confidentiality, Applicant amends A. 23-05-006 to include Exhibits B, C and D while excluding them from the Public Version of this Amendment.

Wherefore, Applicant amends A. 23-05-006 to include Exhibits B, C and D
