**ADMINISTRATIVE LAW JUDGE'S RULING GRANTING JOINT MOTION  
OF LIBERTY UTILITIES AND THE PUBLIC ADVOCATES OFFICE REQUEST  
TO SUSPEND THE REMAINING PROCEEDING SCHEDULE**

## Summary

This ruling grants the joint motion of Liberty Utilities (Cal Peco Electric) LLC and the Public Advocates Office to suspend the remaining procedural schedule in Application (A.) 22-02-008.

### 1. Motion to Suspend Procedural Schedule

On May 24, 2023, Liberty Utilities (Cal Peco Electric) LLC and the Public Advocates Office filed a joint motion to suspend the remaining schedule for A.22-02-008.

In the joint motion, the parties state that they: (1) have engaged in productive settlement discussions; (2) have settled all the issues and therefore, believe that there are no remaining evidentiary issues to be addressed so further testimony, evidentiary hearing, or briefs are no longer needed; and (3) the joint parties intend to submit a motion for adoption of an all-party settlement agreement in A.22-02-008 by June 16, 2023. On this basis, I find that it is reasonable to suspend the remaining schedule for A.22-02-008.

### **IT IS RULED** that:

1. The schedule adopted in the March 2, 2023 Administrative Law Judge's Ruling is hereby suspended.

2. Liberty Utilities and the Public Advocates Office shall submit a motion for adoption of an all-party settlement agreement in Application 22-02-008 by June 16, 2023.
