**ADMINISTRATIVE LAW JUDGE’S RULING DIRECTING SOUTHERN CALIFORNIA GAS COMPANY, SAN DIEGO GAS & ELECTRIC COMPANY AND PACIFIC GAS AND ELECTRIC COMPANY TO FILE AMENDED 2023 GAS INVESTMENT ANNUAL REPORTS**

**Summary**

On March 1, 2023, Southern California Gas Company, San Diego Gas & Electric Company (together the Sempra companies), Pacific Gas and Electric Company (PG&E), Southwest Gas Company and Gill Ranch Storage, LLC (Gill Ranch), each filed a 2023 Annual Report of Planned Gas Investments (Annual Report), required pursuant to General Order (GO) 177, adopted in Decision (D.) 22-12-021. Gill Ranch and Southwest Gas Company, each stated that they had no projects planned that exceed \$50 million or meet the criteria in Section IV(A)(1)(b) of GO 177. PG&E and the Sempra companies filed 2023 Annual Reports, each listing several projects that meet the criteria in GO 177 Section X(A).

The 2023 Sempra companies’ and PG&E’s Annual Reports lacked certain information identified in GO 177. This ruling directs the Sempra companies and PG&E to file Amended 2023 Annual Reports within 20 days of issuance of this ruling and are directed to add the following additional information:

Sempra companies:

For projects 1 through 17:

- The anticipated in-service date, with projects listed chronologically by anticipated in-service date;
- Information required in GO 177 Sections X(C)(1) – (5) and Sections X(C) 7 – 8); and
- An explanation of how the “project” was defined in each case.

For projects 9 and 10:

- Information required in GO 177 Section X(D) and in GO 177 Section X(C)(6). If the Sempra companies need additional time to file information required in GO 177 Section X(D)(1) for projects 9 and 10, they shall include in their filing a 2023 date by which they will file this information.

PG&E:

For all three projects:

- Information required in GO 177 Sections X(D)(1) – (2) and Section X(D)(3). If PG&E needs additional time to file information required in GO 177 Section X(D)(1), it shall include in its filing a 2023 date by which it will file this information.

The Sempra companies and PG&E shall also include the information identified above in their 2023 Second Amended Annual Reports that shall be filed later in 2023 pursuant to Ordering Paragraph 11 of D.22-12-021.

**IT IS RULED** that:

1. The Sempra companies and Pacific Gas and Electric Company shall file Amended 2023 Annual Reports within 20 days of issuance of this ruling, adding the information outlined in this ruling.

2. The Sempra companies and Pacific Gas and Electric Company shall include the information identified above in their 2023 Second Amended Annual Reports that shall be filed later in 2023 pursuant to Ordering Paragraph 11 of D.22-12-021.
