# ADMINISTRATIVE LAW JUDGE'S RULING CORRECTING DISTRIBUTION PLANNING ADVISORY GROUP SCHEDULE FOR 2023-2024 DISTRIBUTION INVESTMENT DEFERRAL FRAMEWORK CYCLE

This ruling adopts a corrected Distribution Planning Advisory Group Schedule for the 2023-2024 Distribution Investment Deferral Framework Cycle (DPAG Schedule for 2023-2024 DIDF Cycle), which is appended to this ruling as Attachment A.

The May 19, 2023 Administrative Law Judge's Ruling on Recommended Reforms for the 2023 Distribution Investment Deferral Framework Process, the Partnership Pilot, and the Standard-Offer-Contract Pilot (2023 DIDF Reform Ruling) adopted an updated DPAG Schedule for 2023-2024 DIDF Cycle (see Ruling Paragraph No. 2) that included dates for the Standard-Offer-Contract pilot. However, the 2023 DIDF Reform Ruling determined that, "to ensure protection of ratepayer funds, the Standard-Offer-Contract pilot should not be continued, and no further solicitations should occur." Accordingly, this ruling corrects the DPAG Schedule for 2023-2024 DIDF Cycle) to delete references to the Standard-Offer-Contract pilot.
