ADMINISTRATIVE LAW JUDGE'S RULING SETTING DEADLINE TO RECEIVE DATA REQUESTS ON ELECTRIFICATION STUDY

On May 9, 2023, the California Public Utilities Commission (Commission) issued an *Administrative Law Judge Ruling Setting a Workshop Admitting into the Record Part 1 of the Electrification Impacts Study and Research Plan and Seeking Comment* (EIS Ruling). In response to a request from Pacific Gas and Electric Company, San Diego Gas & Electric Company and Southern California Edison

Company, the assigned Administrative Law Judges extended the deadline as indicated in the table below.

Since extending the deadline to file responses to the EIS Ruling, the Commission has received data requests from the following parties: Pacific Gas and Electric Company, San Diego Gas & Electric Company and the Public Advocates Office of the California Public Utilities Commission. These data

requests ask for an extensive amount of data related to the EIS. In order to ensure parties are able to meet the filing deadlines in the table above, it is necessary for the Commission to establish a deadline of June 19, 2023, by which parties may submit a data request with respect to the EIS Ruling. However, parties are encouraged to submit such data requests as soon as possible.

Further, to provide a transparent process, parties are directed to send all data requests to the entire service list of this rulemaking by email with the following subject line: **R2106017 EIS Ruling Data Request**. If a party wishes to receive the same data that another party has requested, submission of a data request is necessary. Due to the potential amount of data that may be necessary to fulfill a data request, it may not be technologically feasible to send data request responses to the entire service list. With respect to potential confidentiality issues pertaining to certain data categories, decisions on data requests will be made on a case by case basis.

IT IS RULED that:

1.
