## ADMINISTRATIVE LAW JUDGE'S RULING SETTING STATUS CONFERENCE

After service of concurrent opening testimony, concurrent rebuttal testimony, and concurrent sur-rebuttal testimony on December 12, 2022, January 18, 2023, and February 8, 2023 respectively, this ruling sets the status conference for Wednesday, July 26, 2023 at 1:00 p.m.

On July 21, 2023, the parties will serve and file status conference statements. Prior to filing the status conference statements, the parties will meet and confer to assess whether agreement exists about the procedural steps, the disputed issues of material fact, or discovery issues. The status conference statements will address the following:

- 1. Potential disputes of material fact,
- 2. Plans for discovery, and possible discovery disputes,
- 3. Witnesses who will be available for cross examination if an evidentiary hearing is held, and
- 4. A proposed schedule.

The status conference statement of SoCalGas will summarize the result of any meet and confers where the parties made efforts to informally resolve issues. If the parties agree on a joint status conference statement, they may elect one party to file that status conference statement on their behalf.

During the status conference, the Webex Link will provide the video and the telephone conference line will provide the audio. The July 26, 2023, 1:00 p.m. status conference remote participation information is as follows:
