**ADMINISTRATIVE LAW JUDGE’S RULING
ADMITTING TESTIMONY AND EXHIBITS INTO THE RECORD
AND EXTENDING DUE DATES FOR OPENING AND REPLY BRIEFS
ON PHASE II DEMAND RESPONSE ISSUES**

Pursuant to Administrative Law Judge direction, on June 23, 2023, the parties in this proceeding submitted a Joint Motion for Admission of Evidence Regarding Phase II Demand Response Issues (Joint Motion). Attachment A to the Joint Motion included an exhibit list. No objections to the Joint Motion were noted. Good cause being shown, and in the absence of party objection, the Joint Motion is granted, and the exhibits as marked in Attachment 1 to this ruling that have not yet been entered into evidence are formally accepted into the record for consideration in this proceeding.

On June 26, 2023, San Diego Gas & Electric Company (SDG&E) presented a procedural email request for clarification. SDG&E noted a discrepancy in the January 27, 2023 Assigned Commissioner’s Ruling Directing Response to Questions and Energy Division Staff Proposals Related to Application 22-05-002

Phase II Issues and Directing Southern California Edison Company to Submit Capacity Bidding Elect Proposal for Program Years 2024-2027 (ACR).

Particularly, SDG&E noted that the ACR listed two different due dates for opening briefs and reply briefs on Phase II Demand Response (DR) issues.

SDG&E sought clarification regarding the dates, and requested that the later due dates be utilized due to the large record for consideration in the proceeding.

This ruling grants SDG&E's request and sets the due dates for Phase II DR issues as July 14, 2023 for opening briefs and August 11, 2023 for reply briefs.

IT IS RULED that:

1. The exhibits in Attachment 1 to this ruling are formally accepted into the record in this proceeding as marked.

2. The due dates for Phase II Demand Response briefs are set as July 14, 2023 for opening briefs and August 11, 2023 for reply briefs.

This order is effective today.
