On September 29, 2023, Public Advocates Office of the California Public Utilities Commission (Cal Advocates)) sent an e-mail to the service list that requested revised event dates in the modified procedural schedule adopted in a ruling issued on August 2, 2023 should be maintained. Aside from a change in the inperson PPH date from October 26, 2023 to November 6, 2023, specified in a ruling
