Subject: A.23-06-001: Email Ruling Grating the Joint Motion of SCE and CalCCA to File Documents Under Seal

To the Parties of A.23-06-001:

This email ruling grants the joint motion of Southern California Edison Company (SCE) and the California Community Choice Association (CalCCA) to seal excerpts of the evidentiary record in this proceeding.

On September 26, 2023, SCE and CalCCA filed a joint motion seeking confidential treatment for sections of the following exhibits:

- Exhibit SCE-01C 'Energy Resource Recovery Account (ERRA) 2024 Forecast of Operations.'
- Exhibit SCE-02C 'Energy Resource Recovery Account (ERRA) 2024 Forecast of Operations – (Local CPE).'
- Exhibit SCE-04C 'Supplemental Testimony Energy Resource Recovery Account (ERRA) 2024 Forecast of Operations.'
- Exhibit SCE-04C-E 'Supplemental Testimony Energy Resource Recovery Account (ERRA) 2024 Forecast of Operations.'

- Exhibit SCE-05C 'Rebuttal Testimony of Southern California Edison Company in Support of its Energy Resource Recovery Account (ERRA) 2024 Forecast of Operations.'
- Exhibit CalCCA-01C 'Prepared Direct Testimony of Brian Dickman on Behalf of the California Community Choice Association in Southern California Edison Company's 2024 ERRA Forecast Proceeding.'
- Exhibit CalCCA-02C 'SCE Responses to Certain Data Requests Issued in Lieu of Cross Examination.'

Commission Decision (D.) 06-06-006 established standards for designating information as confidential in Commission proceedings by identifying categories of data and the level of confidentiality associated with different categories. Commission General Order (G.O.) 66-D and Public Utilities Code §583 direct parties submitting information to the Commission to request confidential treatment and only redact the portions of the document deemed confidential. In the September 26, 2023, joint motion, SCE and CalCCA stated that the sections highlighted in grey in the confidential documents that were served to the Administrative Law Judge are not already public and cannot be aggregated, redacted, summarized, or otherwise protected in a way that allows for partial disclosure of the information. Publicly available versions of the documents have been separately e-filed and are available on the Commission's e-filed document website.

Good cause being shown, **IT IS RULED** that Southern California Edison Company and California Community Choice Association's joint motion seeking confidential treatment of information within the exhibits listed above is granted, pursuant to D.06-06-006, G.O. 66-D, and Public Utilities Code §583.

The Docket Office shall formally file this ruling.
