## ADMINISTRATIVE LAW JUDGE'S RULING NOTICING PUBLIC PARTICIPATION HEARINGS

This ruling schedules eight public participation hearings (PPHs) in this proceeding and directs AT&T California (AT&T) to provide notice of the PPHs.

## 1. Public Participation Hearings

The PPHs are an opportunity for the public to communicate directly with the California Public Utilities Commission (Commission) regarding the issues raised in this proceeding. The schedule and locations for the PPHs are indicated below. Six PPHs will be conducted in-person and two PPHs will be remote.

# 2. Coordination of Public Participation Hearings with Application (A.) 23-03-002 and A.23-03-003

As noted in the Assigned Commissioner's Scoping Memo and Rulings for both A.23-03-002 and A.23-03-003, the schedules for both proceedings are very related and administrative coordination of the PPHs will be carried forward in both dockets. As part of that, notice of the PPHs will be made in both proceedings via a ruling issued by the assigned Administrative Law Judge (ALJ). Additionally, separate notices will be provided on the Daily Calendar. Members of the public may speak on either application during their allotted time and the transcripts of the PPHs will be served on both proceedings. Additionally, if it is more convenient, AT&T may provide notice to its customers of the PPHs at the same time, using the same document, instead of providing separate notices for both proceedings.

# 3. Notice of Public Participation Hearings

AT&T's instruction to provide notice to its customers of the PPHs in this proceeding includes the following requirements:

- Notice the PPHs as a written insert with a mailed bill to customers that currently receive bills via the United States Postal Service. The notice shall state the dates and times of the PPHs, as well as the location, and other information contained in Attachment A. AT&T shall provide a draft notice to the Public Advisor's Office within ten days of the issuance of this ruling, and the Public Advisor's Office may modify the draft notice;
- Send an e-mail message to all customers who elect to receive their bills via e-mail. The subject line of the e-mail must clearly notify the recipient that the PPHs will be held in this proceeding and include other information contained in Attachment A.
- Publicize the PPHs on all social media platforms; and
- Post notice of the PPHs on AT&T's website in a prominent location so that customers can easily access the notice.

For the in-person PPHs, AT&T shall provide at least one customer service

representative who can assist customers attending the in-person PPHs to assist

with individual service issues, including billing issues.

By no later than five business days prior to the remote PPHs, AT&T shall provide to the Public Advisor's Office the name, title, and telephone number of at least one senior customer service representative who can be reached by customers during the remote PPHs for individual service issues, including billing issues. The representative's contact information provided to the Public Advisor's Office may be posted publicly or announced during the PPHs.

By no later than January 31, 2024, AT&T shall file a letter with the Public Advisor's Office verifying that it has complied with all directives set forth above and attach a copy of the notice for each communication method. For each communication method described above, the letter shall state the dates AT&T sent the notice to customers, the approximate number of customers notified, and the geographic locations covered.

### 4. Summary of Party Positions

Parties shall meet and confer and develop a one-page (double-sided) summary of their positions that uses easily understand terms, without jargon, to explain their positions on the issues that are in the scope of this proceeding, which the ALJ may read or otherwise make available at the PPHs. These meetings may be remote. AT&T's duties shall include organizing the meetings that occur, providing notice to all parties of the meetings, as well as preparing, filing, and serving the required one-page (double-sided) summary. The summaries shall be filed and served by no later than January 15, 2024. AT&T shall have one page and the intervenors shall have one page. The summaries shall use Garamond font in size 12, with 1.5 spacing between lines. Parties also may provide a URL to access more extensive explanations of their positions. These summaries will be posted on the Commission's website.

### IT IS RULED that:

1. AT&T California shall provide notice to its customers of the public participation hearings listed in Section 1 of this ruling, in the manner prescribed in Section 3 of this ruling.

2. Parties shall meet and confer and then develop a one-page, double-sided fact sheet summarizing the positions of all parties. The summaries shall follow the guidance prescribed in Section 4 of this ruling and be filed and served by January 15, 2024.
