Subject: Application 23-08-003, Email Ruling Granting Joint Applicants' November 20, 2023 Motion to Change Name of Joint Applicant

To Parties in A.23-08-003:

On November 20, 2023, Hypercube Networks, LLC, formerly known as Intrado Communications, LLC (U6592C) and 46 Labs, LLC (46 Labs) collectively Joint Applicants filed and served a motion requesting that the Joint Applicant previously identified as Intrado Communications, LLC be identified as Hypercube Networks, LLC moving forward and that the caption of the instant proceeding be revised accordingly.

As Joint Applicants indicate in their motion, the motion is justified on the grounds that Hypercube Networks, LLC changed its name following the filing of the Joint Application by making appropriate filings with the Delaware Secretary of State and the California Secretary of State. In addition, Joint Applicants indicate that the name change has been communicated to the Commission's Communications Division by advice letter submitted pursuant to General Order 96-B.

Based on the foregoing reasons, the pleadings and exhibits filed in support of the Joint Applicants' motion and the oral argument of Joint Applicant Hypercube Networks, LLC at the November 14, 2023, prehearing conference, Joint Applicants' motion is granted, and: (1) the Joint Applicant identified as Intrado Communications, LLC shall now be identified as Hypercube Networks, LLC effective November 20, 2023; (2) the Docket Office shall amend the caption to reflect the name change within ten (10) days of this Ruling; and (3) the Process Office shall update the service list to reflect the name change and amended caption within ten (10) days of this Ruling.
