Subject: A.22-04-001: Email Ruling Directing SCE to Coordinate a Meet-and-
Confer and Submit a Report of the Results

Parties in A.22-04-001,

As set in the Assigned Commissioner's Scoping Memo and Ruling, one of the issues considered in this proceeding is:

What is the revenue requirement equal to the estimated unrealized volumetric sales and unrealized revenue resulting from the Public Safety Power Shutoff (PSPS) events in 2021 that Southern California Edison (SCE) must forgo in accordance with Decision (D.) 21-06-014? What is the appropriate methodology for calculating SCE's unrealized volumetric sales and unrealized revenues resulting from 2021 PSPS events?

On July 3, 2023, D.23-06-054 approves the methodology for calculating unrealized revenues and sales during PSPS events.

This Ruling directs SCE to coordinate a meet-and-confer with the parties in the proceeding to agree on a schedule for the remaining milestones in the proceeding, which should include the dates for submission of SCE's testimony, intervenor testimony, rebuttal testimony, opening briefs and reply briefs specifically on the calculations of estimated unrealized PSPS sales and revenues. Parties may also want to discuss whether hearings are needed and, if hearings are not needed, the date for parties to submit motion or objections for entering this set of testimony into the evidentiary record, preferably after the submission of rebuttal testimony and before the submission of opening briefs. The proceeding will be considered submitted upon receipt of these reply briefs.

SCE shall serve and file a report of the meet-and-confer by December 18, 2023, and include in the report either a proposed schedule with dates agreed upon by the parties or dates requested by the parties if parties could not reach agreement.

IT IS RULED that

- 1) SCE shall conduct a meet-and-confer with the parties in the proceeding to discuss the remaining proceeding schedule, and
- 2) SCE shall file and serve a report of the meet-and-confer by December 18, 2023, and include in the report either a proposed schedule with dates agreed upon by the parties or dates requested by the parties if parties could not reach agreement.

The Docket Office Shall Formally File this Ruling.
