**Subject:** R.23-05-018: Email Ruling Extending Time for Phase 2 Comments and Issuance of Staff Proposal

Good cause being demonstrated, the Joint Motion for Extension of Phase 2 Comment Deadlines, filed on January 8, 2024, by the Sierra Club and Environmental Defense Fund, is granted. The due dates for parties to file comments on the Administrative Law Judges' December 18, 2023 Ruling Inviting Comment on Phase 2 Issues are extended to February 5, 2024, for opening comments and February 26, 2024, for reply comments.

With the extension of the comment deadlines, the date for issuance of a staff proposal on Phase 2 issues is modified to the second quarter of 2024.
