Email Ruling Authorizing Post Prehearing Conference Comments Due Within (10) Business Days

On February 9, 2024, a remote prehearing conference (PHC) was held pertaining to Rulemaking (R.) 23-11-001, Order Instituting Rulemaking (OIR) to Consider Revisions and Updates to the Deaf and Disabled Telecommunications Program (DDTP). The Administrative Law Judge's (ALJ) ruling filed December 21, 2023 that established the remote PHC indicated, among other things, that a sign language interpreter will be present. Due to a scheduling miscommunication, no sign language interpreters were present at the remote PHC. After conferring with the parties, deaf participants indicated they were able to follow the remote PHC by using the Closed Captioning function in Webex, and submit their comments in the chat function, which the ALJ would then read aloud for the court reporter. With this information the ALJ decided to continue with the PHC.

To ensure that all parties are able to fully comment on the proceeding, including the scope, schedule, and procedural matters; parties are authorized to submit written comments regarding topics covered in the PHC. Comments shall be no more than (5) pages in length. Comments shall be sent to the service list within (10) business days.
