Subject: A.23-03-002 Email Ruling from Assigned ALJ re: response time for Second CforAT Motion to Compel

To All Parties:

This email ruling sets a deadline of April 4 to respond to the Motion to Compel, filed by CforAT on April 2, 2024.

Rule 11.1(e) allows an Administrative Law Judge to set a different deadline for responses than the ten days allowed for in Rule 11.3 (b). Given that the evidentiary hearing is one week away, I have determined to shorten the time period for responses to this motion.

Previous motions to compel were filed late in the afternoon or early evening. In this case, CforAT's motion was filed before 8:30am, and this ruling is being issued before 9:30am. Thus, consistent with response deadlines to other recent motions to compel, parties will have three business days to respond.
