Subject: A.23-01-008: E-mail Ruling Accepting UCAN's Notice of Intent to Claim Intervenor Compensation and Superseding Prior Rulings

To the Service List in Application 23-01-008:

On June 16, 2023, the Utility Consumers' Action Network (UCAN) filed a motion that requested late acceptance of its Notice of Intent to Claim Intervenor Compensation (NOI) in this proceeding. In the motion, UCAN claimed that it unintentionally did not file the NOI by the June 9, 2023, deadline. Instead, UCAN served the service list for this proceeding and sent the NOI in the original word document form to the Intervenor Compensation (IComp) Coordinator at the California Public Utilities Commission (Commission) on June 9, 2023, at 1:49 pm.

On June 23, 2023, an Administrative Law Judge (ALJ) ruling granted UCAN's motion based on good cause. The ruling was e-mailed to the service list in this proceeding but was not filed on the Docket Card.

On April 12, 2024, an ALJ ruling denied UCAN's NOI because UCAN did not comply with Public Utilities Code Section 1804(a)(1) which requires intervenors in this proceeding to file and serve a NOI by June 9, 2023, 30 days after the Pre-Hearing Conference.

Upon further review, UCAN timely filed its NOI by sending it to the Commission's IComp Coordinator on June 9, 2023. Having shown due cause, this ruling supersedes the June 23, 2023, and April 12, 2024, rulings and accepts UCAN's NOI to Claim Intervenor Compensation in this proceeding.

It is so RULED.
