Subject: A.20-11-001: Ruling Directing Center for Accessible Technology to Refile Settlement Pursuant to Rule 12.1

Attention All Parties:

This Ruling directs Center for Accessible Technology (CforAT) to refile Attachment A to its February 22, 2024, Motion to Withdraw as a Motion for Settlement under Rule 12.1 of the Commission's Rules of Practice and Procedure.

On November 18, 2021, the Commission issued Decision (D.) 21-11-030, approving Verizon Communications Inc.'s (Verizon) proposed acquisition of TracFone Wireless, Inc. (TracFone) with conditions. On July 27, 2023, TracFone and Verizon filed a Petition for Modification of D.21-11-030. On October 6, 2023, CforAT filed a Petition for Modification of D.21-11-030. On February 22, 2024, CforAT filed a Motion to Withdraw its Petition for Modification, and included as Attachment A, a proposed Settlement between CforAT, TracFone, Verizon, and The Utility Reform Network. To properly evaluate the proposed settlement, CforAT is directed to refile Attachment A to its Motion to Withdraw, as a Motion for Settlement under Rule 12.1 of the Commission's Rules of Practice and Procedure.
